#### ARE YOU WITHIN REACH? by Dennis Facchino

In my 17 year involvement in public education with both teachers and counselors and nearly 10 years with marriage and family therapists, I have become aware of an interesting phenomenon among professionals. I would like to address this through the medium of a story and encourage your involvement in the Santa Clara Valley Chapter.

In suburban Houston near a fashionable shopping center occupied by wonderful, exciting and novel shops lives the Allred family. Al and Martha Allred both work, have four children, all adolescents ranging in ages from 13 through 17, a five bedroom home and a lot of things to manage within the household. Getting help from family members has been a frustrating and never-ending task for Martha.

Not too long ago she and Al took a short course in teaching parents to be more effective managers within the family. It was becoming very obvious that their authority was incapable of getting most of their children to perform the daily tasks. The course instructed parents to organize children into small groups or committees for accomplishing the chores. These might include garbage, cooking, dish washing, house cleaning, shopping, and driving the younger children to various events.

As one might expect the children were less than enthusiastic about these committees. They had enough to do with their school demands, social activities, sports and recreational endeavors. And furthermore, these were parental responsibilities and not those of the children. The children believed, and rightly so, they had a small part that really didn't amount to much if they didn't participate.

If you were to take the children aside and interview them, most if not all would agree they were benefiting from the labors of those who were doing their part. However, they continued to remain unconcerned unless it was most important to them. They believed the family has functioned "pretty darn good" with Mom and two of the children doing most of the chores.

One segment of the course dealt with motivation. Just how does one get somebody to do something? The instructor admitted that this was the most difficult part of the course. Reports from previous students had not been promising. Never-the-less, Martha and Al began providing their children with some additional plums: an extra \$5/week allowance, dessert with each evening meal and an occasional concert ticket.

It became only too evident that this wasn't going to corral those children who were already benefiting. Why should they begin doing things and helping out when they eventually get what they want and need anyway? Martha and Al began talking about "seeking help" from a professional family counselor or mediator to get their children involved with the family. It just didn't seem fair to them, nor those kids who were working, to carry the others. It's not as if they have to do everything! Al and Martha reasoned, if most would give some help, not only would they all be happier but the end product would be fantastic. Self-esteem, not to mention individual and collective wealth, would rise measurably.

Again renewed with enthusiasm, Al and Martha approached their kids telling them we are going to seek professional help. The problem of too many of you letting the rest of us do the bulk of the work, has gone beyond what is reasonable and fair. The kids balked at the idea, shouted unkind things beneath their breath and left the room. they, at least for the time being, were unreachable!

Be reachable...we need you and the "family" needs you...your creativity and energy are a valuable resource to your organization.


