#### 117 -- SCV-CAMFT SUPPORT GROUP LEADER AND ATTENDEE CRITERIA

### I. Purpose

The purpose of this document is to provide policies and procedures for SCV-CAMFT sponsored support groups.

#### II. Policy

It is the policy of the chapter to encourage the use of SCV-CAMFT chapter support groups and provide leaders with policies and expectations and to provide rights and expectations to participants.

#### III. Procedures

#### **General Information:**

- 1. New groups may be formed by following the guidelines of P&P 103 Approval of Activities.
- 2. The SCV-CAMFT board shall designate a board member as the contact person for all support group leaders.
- 3. The Board may vote to dissolve a group and/or change a group leader at its discretion. Areas to be considered for such a decision will include issues such as: lack of participant interest, negative feedback from participants, leader's failure to follow this policy, leader's failure to pay dues, leader's withdrawal or dismissal from the chapter, etc.
- 4. State CAMFT holds the position that if a fee is charged for a group, that the revenue should not go to the group facilitator(s), but to the chapter, since receiving compensation goes against the principle of a not-for-profit volunteer.

## **Goals and Expectations of Leaders:**

- 1. Group leaders shall be SCV-CAMFT chapter members in good standing, and be current on SCV-CAMFT and State CAMFT dues.
- 2. Group leaders shall obtain group participant names and telephone numbers from all group participants at the time of the group, using Appendix 117-A.
- 3. Group leaders shall send appendix 117-A to the Chapter Coordinator within 2 (two) business days of the completion of a group, either by US mail to:

- 4. Group leaders shall give the SCV-CAMFT board at least 60 days written notice of their intention to stop facilitating a group.
- 5. Group leaders shall give group participants as much warning as possible that they intend to stop facilitating a group.
- 6. Group leaders shall commit to a year of service and shall maintain consistent meeting times/locations that agree with what has been advertised in the chapter newsletter. Changes may be made if enough time is allowed for proper advertising of a given time/location change.
- 7. Group leaders shall inform group participants of their Rights by presenting them with Appendix 117-B at their first group appearance.

#### **Additional Information:**

- 1. Since participation in an SCV-CAMFT sponsored support group requires chapter membership, the board allows you the opportunity to participate in a group up to 2 (two) times before deciding to join the chapter.
- 2. In the past, there was confusion about Interns receiving 3:1 BBS credit for support groups. The BBS's position is that "support" is not "psychotherapy." Since this is the case, MFT interns may not receive credit for their hours at the 3:1 rate from the BBS, specifically because the chapter does not have psychotherapy liability insurance; therefore support groups are not psychotherapy and do not qualify.
